MOTION

Neighborhood Councils were awarded funds from the Innovation Fund (IF) for the Clean LA Contest. The first \$25,000 was deposited into the Department of Neighborhood Empowerment's Budget Fiscal Year 2016, Fund 44B, and Appropriation Account 47M240 (account name: Clean LA Contest - Neighborhood Council). Per the original contest guidelines, Public Works and Neighborhood Empowerment were instructed to incentivize neighborhood cleanups by having Neighborhood Councils partner with other community organizations and offer them a portion of the award money. Although the City would only issue the award money to the lead applicant, the guidelines recommended that the organizations come to an agreement on how to distribute and share the award. The original fund transfer instructions did not clearly address how Neighborhood Empowerment would disburse the funds properly to the Neighborhood Council and how the award money could be shared with partnering community organizations per the recommended guidelines of the Clean LA Contest.

I THEREFORE MOVE that item 3 on the adopted Council file 16-0276, subject to the approval of the Mayor, be revised to state the following:

3. INSTRUCT the Department of Neighborhood Empowerment to:

- a. Review and approve any further funds to be continuously received for the Clean LA Contest monetary prize to ensure that funds are expended in a manner that is consistent with either the Neighborhood Council (NC) Funding Program guidelines, or the Clean LA Contest guidelines for sharing the award between the lead applicant and partnering community organizations so long as an agreement was made prior to receiving the award.
- b. Keep the source funds separate from the NCs' City appropriation accounts and keep on deposit in the "Clean LA Contest - Neighborhood Council" account 47M240 to prevent commingling of these funds with regular NC appropriation accounts.
- c. Utilize the NCs' bank account process in the expenditure of these funds. For the first \$25,000, and any further funds received, please see the attachment with NCs names.
