On the night of 10 May 63, I met LITAMIL-9 at the usual rendezvous point and we drove to outlying district of city where debriefing took place. NO SECURITY PROBLEMS NOTED.

1. <sup>201-33253</sup> (LITAMIL-9) reported as follows: Manuel VEGA Perez, Cuban G-2 Mexico, told (L-9) that he had been with Dolores DE LA MORA Canada and that DE LA MORA asked for (L-9). (L-9) of course, will take advantage of VEGA remark to make contact with DE LA MORA. (L-9) commented that fact VEGA was with DE LA MORA is interesting. It will be recalled that "Conchita" FERNANDEZ told (L-9) to be careful with DE LA MORA because she is a contact of CLERGE Fabra, Cuban G-2 type.

2. (L-9) reported that on 9 May 63, while near the Cine Diana at IZEX 10:30, he saw Ramon SINOBAS Canada waiting for someone. SINOBAS saw (L-9) and waved at him. (This was KUBARK meeting) (L-9) commented that SINOBAS was definitely waiting to make a contact with someone.

3. Francisco MAIZ Alberdi, Spanish/Cuban, who formerly tended the gate at the Cuban Embassy in Mexico, returned to Mexico on 10 May 63, this time assigned to the Embassy as "Auxiliar de Seguridad" (LITRE Airlifts know MAIZ and his wife returned via Gubara on 10 May 63). (L-9) said that MAIZ' wife is suffering from cancer, that she was operated on in Habana but there is no hope.

4. (L-9) reported that on 9 May 63, Ramon SINOBAS Canada, Cuban Charge, met with students (about 6) from Chapingo. The meeting took place at 1:00 at the Embassy.

5. Poo. MAIZ told (L-9) that EZEKIEL Hector GALLO Portieles, Cuban Charge in Bolivia, went back to Habana recently for what he thought was short stay, i.e. two weeks, but he is still there. GALLO was assigned to study "instruccion politica y revolucionaria"

6. MAIZ also told (L-9) that Rogelio RODRIGUEZ Lopez, formerly in Mexico received a scholarship. It is not known what kind for where.

7. MAIZ told (L-9) that Haberto JORRIN was expected to return to Mexico on 13 May 63. MAIZ said that Anselmo GARCIA Lara was expected to return to Mexico shortly.

8. L-8 said that he had the duty (security) all day Saturday, 11 May 63. (L-9) said that Jose LLAGONTERA is taking the day off and will not return until about 2200 this evening. I told (L-9) to report any similar info particularly re Armando SARDINAS and others who live at the Embassy.

9. MAIZ told (L-9) that Eusebio AZCUE was expected back in a week or so. MAIZ said that his wife would return after him. He added that Sra de AZCUE is anxious to return to Mexico.

10. (L-9) finally identified Jose FERNANDEZ Roa as the person who is working with Buenaventura REYES Acosta and Ramon SINCERES. (L-7) reported this previously (L-9) said he asked FERNANDEZ if he was related to the Foreign Minister and FERNANDEZ didn't say yes or no. (L-9) believes that he might be because he doesn't seem very sharp and yet he's hanging around with SINCERES and BUENAVENTURA. FERNANDEZ told (L-7) who asked him about his relationship with ROA, that if he was related to ROA it was a distant relationship.

11. Coty SOLORZANO, sister in law of Gral. Lagaro CARDENAS is scheduled to leave for Habana on 13 May 63.

12. L-9 said he attend a meeting at the Academia Mexicana de Derecho Internacional on 8 May 63 and the Mexican Amb to Israel spoke re non-intervention and autodeterminacion. (L-9) said the speech was typical of Mexican govt policy re Cuba.

13. (L-9) said that he saw Rafael PEDROSA Perez and Antonio AREUZA Mon at the Embassy on 9 May 63. ~~XXXXXXXX~~ They were in session with Ramon SINCERES. PEDROSA, the mulatto type, told L-9 at the inaugural session of the Microonda Seminar that "it was necessary for him to make a lot of contacts in Mexico". It was he who also told (L-9) that he was in contact with Raul ROA, i.e. "Estoy en contact con ROA". (L-9) said that on 9 May at the Embassy, PEDROZA was sick, i.e. pale green, bad breath etc. I told (L-9) to make contact with PEDROZA and AREUZA if possible and size them up. He said it would be difficult because he has no reason to see them. He merely attended the inaugural session of the Seminar. (L-9) however, did identify both men from LIERODE "take" which I showed him on this date.

L-9 said that [redacted] through L-7 [redacted] MORIN, according to [redacted] [redacted] recently. She is living at [redacted] [redacted] suggested that a ltr be written to her asking her to come to the Embassy at which time the CO could interview her. He said that [redacted] was told at the Embassy that it would take about a month to get clearance etc, that she had to be investigated. L-9 pointed out that Embassy request she report for interview would appear to be as past this investigation.

15. L-9 brought a contract to the meeting re his brother's company and [redacted]. He pointed out that the contract was signed on 7 Mar 65 and he left for Habana on 4 March. Because he was not present his name did not appear in the contract and he was unhappy that this had to be. L-9, however, diplomatically and politely pointed out that he want to bring this to my attention to show that this had been a sacrifice on his part, i.e. his travel to Habana on only pennies. I asked L-9 whether this meant anything to him in dollars and cents and he said it did not. He said the only thing was that if his name appeared as the Administrator of the Company when the contract was signed with [redacted] it would give him a feeling of accomplishment and security re his future relationship with the company.

16. L-9 identified the following from LITROV's photos [redacted]

17. L-7 reported that the Gabin FERNANDEZ who was invited to and attended the Cuban Embassy cocktail on 19 Apr 65, is XXX married to a Cuban woman and has been to Cuba several times. L-9 said that XXXXXXXXX FERNANDEZ has a home near Acapulco, where Rusebio ARSOX has stayed on occasions.

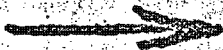

On 13 May 69, I met (LITANIL-9) at the usual rendezvous point and we drove to outlying district of the town, where we held meeting. TOP SECURITY PROBLEMS NOTED. Time: 2230-2330.

(LITANIL-9) provided the following information:

1. Francisco MAIZ A. told (L-9) that Emma FARIAS, former upstairs maid at the Cuban Embassy, and now employed by the PORTUGUESES in Oriente (Amb Jose PORTUGUEDO) is being returned to Mexico as a security risk. She is expected to arrive from one day to the next. According to MAIZ, FARIAS was "sacking in" with anybody who came along, and has even become friendly with counter-revs. In view of the above, FARIAS is being "bounced". MAIZ said the Cubans plan to conduct a full body search of FARIAS when she leaves Cuba, i.e. ~~XXXXXXXX~~ "en cueros". (L-9) pointed out that FARIAS is a Mexican and if it true what MAIZ reporting about body search etal it would be good for FP play in Mexico.

2. (L-9) reported that Andres ARMONA, in Tannica 261-933036, *Armona Ramon, Andres Nicola*

3. Jose FERNANDEZ ROA, newly arrived Cuban dip, told (L-9) that he came to Mexico in 1959 with a group of young people as an "official". FERNANDEZ said that Amb MASSIP was in Mexico at that time. (L-7) reported that this is FERNANDEZ first overseas post.

4. Roberto JORRIN is expected to return on 14 May 69.

5. (L-9) reported that Ovidio SABA, the Vice Consul in Veracruz, is quite sick with "turistas", i.e. amoebas. He apparently has had this problem in Cuba.

6. Ramon SINOBAS, Cuban Charge, told (L-9) that his baby would be about a week old when the new Ambassador arrived and that this would be fine because he wanted to return to Cuba and see his father who has returned to Habana from Paris (Ramon SINOBAS del Olmo). SINOBAS' wife gave birth to baby boy.

7. Manuel VEGA Perez told (L-9) that the new Amb Joaquin HERNANDEZ de Armas "llegara a mas tardar en diez dias".

U. On 12 May 59, ~~Rafael~~ DUNIN, Soviet Counselor, drove L-9 to the Cuban Embassy from Deyocan. DUNIN, who in L-9's opinion is extremely "sharp", "realistic" and "talented" told L-9 the following:

a. The Cuban Rev is now consolidated as the recent trip of Fidel CASTRO to Moscow proves. DUNIN said that CASTRO's absence from Cuba did not affect the regime; that things went on the same in his absence etc. DUNIN, however, said that this does not mean that Cuba does not need CASTRO. He said that Cuba is not like the Soviet Union where the loss of KRUSCHEV would not affect the regime, Cuba needs CASTRO and he must be protected to avoid an assassination attempt etc.

b. (L-9) asked ~~XXXXXXXX~~ DUNIN about the "tapado" and DUNIN answered that at this time, in his opinion, not even the President LOPEZ M., knows who is going to be the candidate.

c. DUNIN stated that a revolution in Mexico similar to that in Cuba would be very difficult. He attributed this to the fact that the masses in Mexico ~~are~~ <sup>do</sup> not ~~have~~ <sup>have</sup> the "debidamente preparacion politica" required for such a revolution. He said that it will take one or two generations before Mexico is ready for such a revolution.

9. L-9 (said that Eusebio AZCUE Lopez, Cuban Consul, is expected back on 17 May 59.)

10. L-9 said that while he was in Habana he asked that 5 copies of Bohemia be sent to the Embassy. He said that 10 copies are arriving each week since his return to Mexico. He said very little propaganda is coming.

11. L-9 said that he saw Rafael PEDROSA and Antonio ARRUZA at the Embassy but he did not have a chance to talk with them. He said they quickly slipped into SINORAS' office.

On 14 May 63, I met (LITAMIL-9) at usual rendezvous point and we drove to outlying area to hold meeting. NO SECURITY PROBLEMS NOTED. Time: 2200-2300

(LITAMIL-9) provided the following info:

1. L-9 had dinner at the Embassy on 14 May and he identified Emigdio VEGA Calero as a TDYer. L-9 said that Emmanuel CARRALLO told him that "Chiquis" BARSAMENDI (sic) employed by the Casa de las Americas is coming to Mexico soon for a couple of weeks. BARSAMENDI, fnu, Subject's father lives in Mexico and according to CARRALLO, was disappointed that his daughter was not going to stay in Mexico. Subject's mother is living in Miami.

2. L-9 reported that Seydou DIALLO, Guinean Amb/arrived on Cubana on 14 May 63 and he saw to it that DIALLO had no problems at the airport. DIALLO is the Guinean Amb to the U.N. also. DIALLO told L-9 that Carlos LECHUGA, Cuban Amb to the U.N. was highly respected by all members of the U.N., including the U.S. He said that LECHUGA knew how to handle himself in the very complicated U.N. maneuvers. DIALLO said that RAUL FERRERES and LECHUGA make a good team. L-9 said that DIALLO is very much pro-CASTRO and undoubtedly a member of the pro-CASTRO U.N. clique. DIALLO told L-9 that he has known Vicente VOLTARDO Salcedo for many years.

L-9 also identified Jose BERNANDEZ Ron in LIFE photo at 507 Embassy press fiesta recently.

4. L-9 said that Fanel VEGA Perez told Rafael PIEROSA Arandia and Antonio ARRUZA Mon. that she should not leave any docs or papers at their hotel room. In fact, both men left immediately to get papers from their room. L-9 believes they are staying at the Hotel Agnes.
