The vision of OPEN is to activate underutilized and vacant downtown properties by introducing new creative, dynamic, temporary retail locations that are visually aesthetic and create an environment that engages customers and authenticates downtown as a vibrant urban space for long-term investment.

The ProposalTo offer established business operators a no cost, short-term lease from December
3, 2013 through December 28, 2013. We would like to make the spaces available by
November 15, 2013 for the participants to begin setting up their storefronts.

This opportunity will be offered through an application process (interest sheet attached). Businesses will be selected based on the appeal of their product mix for holiday shoppers, how well their concept works in synergy with current full-time tenants, their ability to add excitement to the festive holiday atmosphere through in-store events, promotions, and the quality of their window displays.

OPEN will promote the locations and hours of these new stores in conjunction with advertising and marketing of downtown holiday events and activities.

These short-term tenants will agree to be open certain hours, which will include daytime and evening hours on Tuesdays and Saturdays up through December 28th. OPEN participants will also be required to attend a planning/kick-off meeting (date to be announced).
