Overview

The [U.S. Department of Justice](#) (DOJ), [Office of Justice Programs](#) (OJP), [National Institute of Justice](#) (NIJ), is seeking applications to fund studies that advance knowledge and understanding in the following three categories: (1) juvenile indigent defense in delinquency proceedings; (2) co-occurring mental health and substance use disorders in juvenile residential facilities; and (3) assessing dual system youth data linkage capacity across juvenile justice and child welfare systems. This program furthers the DOJ's mission by supporting the development of new knowledge and tools to address the challenges of crime and justice in the United States.

This solicitation incorporates the [OJP Grant Application Resource Guide](#) by reference. The OJP Grant Application Resource Guide provides guidance to applicants for the preparation and submission to OJP of applications for funding. **If this solicitation expressly modifies any provision in the OJP Grant Application Resource Guide, the applicant is to follow the guidelines in this solicitation as to that provision.**

For purposes of this solicitation, "state" means any state of the United States, the District of Columbia, the Commonwealth of Puerto Rico, the Virgin Islands, Guam, American Samoa, and the Commonwealth of the Northern Mariana Islands.

To advance Executive Order 13929 Safe Policing for Safe Communities, the Attorney General determined that all state, local, and university or college law enforcement agencies must be certified by an approved independent credentialing body or have started the certification process, to be eligible for FY 2022 DOJ discretionary grant funding. To become certified, the law enforcement agency must meet two mandatory conditions: (1) the agency's use-of-force policies adhere to all applicable federal, state, and local laws and (2) the agency's use-of-force policies prohibit chokeholds except in situations where use of deadly force is allowed by law. The certification requirement also applies to law enforcement agencies receiving DOJ discretionary grant funding through a subaward. Foreign governments, foreign organizations, and foreign colleges and universities are not eligible to apply. Federal agencies are eligible to apply. (Any award made to a federal agency will be made as an inter-agency reimbursable agreement.)

All recipients and subrecipients (including any for-profit organization) must forgo any profit or management fee.

NIJ will consider applications under which two or more entities would carry out the federal award; however, only one entity may be the applicant. Any others must be proposed as subrecipients (subgrantees). For additional information on subawards, see the [OJP Grant Application Resource Guide](#).

NIJ may elect to fund applications submitted under this FY 2022 solicitation in future fiscal years, dependent on, among other considerations, the merit of the applications and the availability of appropriations.

Applications will be submitted to DOJ in two steps:

Step 1: The applicant must submit by the Grants.gov deadline the required Application for Federal Assistance

standard form (SF)-424 and a Disclosure of Lobbying Activities (SF-LLL) form when they register in Grants.gov at <https://www.grants.gov/web/grants/register.html>.

Beginning April 4, 2022, the Federal government will cease using the Data Universal Numbering System (DUNS) number to uniquely identify entities. At that point, entities doing business with the Federal government will use a Unique Entity Identifier (UEI) created in SAM.gov. If your entity is currently registered in SAM.gov, your UEI has already been assigned and is viewable in SAM.gov. This includes inactive registrations. If you are a new entity registering in SAM.gov, you will continue to register in SAM.gov using the DUNS number assigned by Dun and Bradstreet (D&B) until April 4, 2022. Program Description

Overview

OJP is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

With this solicitation, NIJ, in collaboration with the Office of Juvenile Justice and Delinquency Prevention (OJJDP), seeks proposals for rigorous research and evaluation projects that inform policy and practice in the field of juvenile justice. Specifically, this solicitation seeks proposals for studies that advance knowledge and understanding in the following three categories: (1) juvenile indigent defense in delinquency proceedings, (2) co-occurring mental health and substance use disorders in juvenile residential facilities, and (3) assessing dual system youth data linkage capacity across juvenile justice and child welfare systems. Applications proposing research outside of these three categories will not be considered.

Applications proposing research involving partnerships with juvenile justice, criminal justice, child welfare, mental health, substance use treatment, or other agencies, should include a strong letter of support, signed by an appropriate decision-making authority from each proposed, partnering agency. A letter of support should include the partnering agency's acknowledgement that de-identified data derived from, provided to, or obtained through this project will be archived by the grant recipient with the National Archive of Criminal Justice Data (NACJD) at the conclusion of the award. Applicants and their potential partners are encouraged to review the NACJD's policies and protections at ([NACJD](#)). If selected for award, grantees will be expected to have a formal agreement in place with partnering agencies by January 1, 2023. That formal agreement must include a provision to meet the data archiving requirements of the award.

In the case of partnerships that will involve the use of federal award funds by multiple partnering agencies to carry out the proposed project, only one entity/partnering agency may be the applicant (as is the case with any application submitted in response to this solicitation); any others must be proposed as subrecipients.

Statutory Authority

Juvenile Justice and Delinquency Prevention Act of 1974 (section 221); Department of Justice Appropriations Act, 2022, Public Law 117-103, 136 Stat. 49, 128-129; 28 USC 530C.

Specific Information

NIJ works closely with OJJDP to support high-quality, rigorous research, evaluations, and statistical analyses related to juvenile justice, as well as preventing and responding to juvenile delinquency and child victimization. The purpose of this solicitation is to invite applicants to propose research addressing one of the three categories described below. Under each category, applicants should propose to conduct scientifically rigorous research studies with an emphasis on informing policy and practice. The proposed study designs may involve a broad range of research methodologies to address the research questions.

Category 1: Research on Juvenile Indigent Defense

In 1967, the Supreme Court held that juveniles have a constitutional right to defense counsel during juvenile delinquency proceedings and are entitled to an appointed attorney in cases of indigency.^[1] However, consistent with the American Bar Association's juvenile justice standards recommendations,^[2] some jurisdictions provide appointed counsel if a minor appears at a hearing without counsel regardless of financial situation.^[3] For the purposes of this solicitation, juvenile indigent defense refers to appointed defense counsel provided to a youth concerning a delinquency matter regardless of determination of financial need.

Juvenile indigent defense systems also vary substantially across the United States with regard to how attorneys are provided, when defense support is available during the course of juvenile justice processing, and what qualifications are possessed by the assigned attorneys. Jurisdictions utilize different methods of providing juvenile indigent defense. Generally, counsel is appointed through any of four ways:

Public Defenders Offices. Public defender offices employ staff attorneys who provide indigent defense

services through a public or private nonprofit organization or as government employees.

- *Assigned Counsel.* Through assigned counsel, attorneys are appointed by the court, at the state level, from a list of private bar members.
- *Panel Attorneys.* Panel attorneys are appointed on a case-by-case basis by the court, at the federal level, from a list of bar members.
- *Contract Attorneys.* Contract attorneys are private attorneys appointed to provide indigent defense services through bar associations, law firms, groups of attorneys, and nonprofit corporations in compliance with legal agreements with state, county or local government.^[4]

Counsel can be appointed at various points during the juvenile justice process. Although some states provide counsel during police interrogation, in other states counsel is only provided when a youth appears in court for the first time.^[5]

Jurisdictions also vary on whether attorneys assigned to represent youth in juvenile court matters specialize in juvenile defense or receive specialized training. The National Juvenile Defense Standards call for specialized training requirements for juvenile defense including familiarity with juvenile delinquency statutes, knowledge of developmental sciences or other relevant research, and effective adolescent interviewing.^[6]

Despite the wide diversity in practices, current knowledge on juvenile indigent defense is largely limited by what data are available from state public defender agencies' annual reports, which generally focus on their staff activities and exclude other types of assigned counsel.^[7]

NIJ seeks proposals for research that advances the understanding of the current indigent defense delivery systems, inclusive of varied types of assigned counsel, and their impact on youth processing through the justice system (e.g. due process, plea bargaining) and case outcomes (e.g. diversion, detention, residential placement, service provision).

Category 2: Research and Evaluation of Co-Occurring Mental Health and Substance Use Disorders in Juvenile Residential Facilities

Youth involved in the juvenile justice system evidence overrepresentation of mental health and substance use conditions, as compared to adolescents in the general population.^[8] As defined by the Substance Abuse and Mental Health Services Administration (SAMHSA), co-occurring disorders (CODs) refer to one or more mental disorders co-occurring with one or more substance use disorders (SUDs).^[9] In research efforts focused on youth held in selected juvenile facilities, there is evidence that these youth experience high levels of multiple psychiatric disorder diagnoses, including CODs.^[10] However, there is a need for further examination of the prevalence of youth in juvenile facilities with CODs, and evaluation of promising strategies to provide treatment that fully addresses the complexities of CODs and provides a pathway to successful recovery and reentry.

NIJ seeks proposals to address *one or both of the following priority topics*: (1) estimating the prevalence of youth in juvenile facilities with CODs, and (2) rigorous evaluation of promising strategies to deliver treatment and recovery support services in juvenile residential facilities that provides promising pathways to successful recovery and reentry. For this solicitation, juvenile residential facilities include detention, corrections, or other placement facilities that hold juveniles charged with or adjudicated for an offense.

Estimating the prevalence of youth in juvenile facilities with CODs

NIJ recognizes that a project assessing national prevalence of youth in juvenile facilities who have been diagnosed with CODs may be beyond the scope of existing data resources and currently available funding. Thus, smaller-scale, developmental design approaches would also be considered. Applications should address representativeness in the selected sites and how this work may lay the groundwork for future national estimates. Applicants may further consider how to address in this estimation process: the comparability across facilities, in terms of diagnostic screening and assessment protocols; and the variety, availability, and provision of specialized treatment and recovery support approaches.

Rigorous evaluation of promising strategies

NIJ seeks proposals using rigorous methodologies which would assess promising strategies to deliver treatment and recovery support services in juvenile residential facilities that address the complexities of CODs and provide

pathways to successful recovery and reentry. Proposals should include the following information:

- Description of the existing CODs treatment and recovery support program(s), including discussion on the availability of implementation guide(s), established diagnostic assessment and referral streams, and specialized service delivery addressing CODs.
- Justification supporting that the ongoing treatment and recovery support program is a promising strategy and suitable for evaluation, which may include discussion of the theory of change and logic model.
- Clearly defined target population and estimated sample size.
- Demonstration of clear support from related partners.
- Plans to conduct a process evaluation/implementation fidelity assessment.
- Plans to conduct an outcome evaluation with specification of types of outcome measures and proposed follow-up period.

Category 3: Research to Assess Dual System Youth Data Capacity

Dual system youth are a subset of “crossover youth” — juveniles who have been victims of maltreatment and also engaged in delinquent acts. The dual system youth population consists of crossover youth who have entered, at some point, both the child welfare and juvenile justice systems. The Dual System Youth Design Study investigators found that at least half of youth involved in the juvenile justice system in selected study sites have touched the child welfare system at some point in their lives.^[11] Dual system youth merit: timely, systematic identification; collaborative service delivery across the child welfare and juvenile justice systems; meaningful assessment of service delivery; and evaluation of the impact of integrated service delivery on key life outcomes. Cross system integration is crucial for advancement of practices by both the child welfare and juvenile justice systems.^[12] An underlying prerequisite for both timely identification of, and effective service delivery to, those who meet the definition of dual system youth is developing the capacity for functional, linked administrative data.

NIJ seeks applications to conduct an in-depth national assessment of dual system youth data capacity at the jurisdictional level to advance research and practice procedures. NIJ is particularly interested in receiving rigorous, mixed-method research proposals that move beyond convenience sampling, and reliance on single data collection methods. In proposing research methods, applicants should clearly describe plans for maximizing the scientific rigor of quantitative and qualitative research methods and analysis strategies. Applicants should indicate the strengths and limitations of the proposed project design with a detailed discussion of issues related to sample selection, generalizability, and validity.

NIJ encourages researchers to approach this field-initiated research creatively in order to maximize the utility of the findings in terms of assessing the current status and also informing the future development of functional, linked administrative data capacity to better serve the needs of dual system youth nationwide.

Evaluation Research

If an application includes an evaluation research component (or consists entirely of evaluation research), the application is expected to propose the most rigorous evaluation design appropriate for the research questions to be addressed. If the primary purpose of the evaluation is to determine the effectiveness or impact of an intervention (e.g., program, practice, or policy), the most rigorous evaluation designs may include random selection and assignment of participants (or other appropriate units of analysis) to experimental and control conditions. In cases where randomization is not feasible, applicants should propose a strong quasi-experimental design that can address the risk of selection bias.

Applications that include evaluation research should consider the feasibility of including cost/benefit analysis. In cases where evaluations find that interventions have produced the intended benefit, cost/benefit analysis provides valuable and practical information for practitioners and policymakers that aids decision making.

Evaluation research projects may also address a wide range of research questions beyond those focused on the effectiveness or impact of an intervention. Different research designs may be more appropriate for different research questions and at different stages of program development. The intervention strategies, setting, other contextual factors, and resources should be taken into account when selecting an evaluation design. In all cases, applications are expected to propose the most rigorous evaluation design appropriate for the research questions to be addressed.

New Investigator/Early Career Opportunity

NIJ is interested in supporting researchers who are early in their careers and new to NIJ's research grant portfolios, specifically non-tenured assistant professors, or equivalent full-time staff scientist positions in a research institution, who propose research on topics relevant to NIJ's Office of Research, Evaluation, and Technology (ORET). To that end, NIJ may, in appropriate circumstances, give special consideration in award decisions to applications proposing such researchers as principal investigators (PIs). To qualify, the proposed PI must at the time of application submission:

- Hold a non-tenured assistant professor appointment at an accredited institution of higher education in the United States or an equivalent full-time staff scientist position at a research institution in the United States.
- Have completed a terminal degree or post-graduate clinical training within the six (6) years prior to September 30, 2022.
- Have never previously received NIJ funding as a PI on a research project with the exception of Graduate Research Fellows or Data Resources Program grantees.

If seeking to be considered for the New Investigator/Early Career Opportunity, the applicant should identify that it is submitting a New Investigator/Early Career proposal on the title page of the application.

Goals, Objectives, Deliverables, and Timeline

Goals

The goal of this solicitation is to generate and advance knowledge, with meaningful implications for juvenile justice policy and practice.

Objectives

The primary objectives of this solicitation are to advance knowledge and understanding in three categories: (1) juvenile indigent defense, (2) prevalence of and/or treatment for co-occurring mental health and substance use disorders in juvenile residential facilities, and (3) assessing dual-system youth data capacity.

Deliverables

Final Research Report. Any recipient of an award under this solicitation will be expected to submit a final research report. Additional information on the final research report requirement for the solicitation is posted on NIJ's [webpage](#). Applicants should plan to deliver a draft final research report 90 days prior to the conclusion of the award.

Required Data Sets and Associated Files and Documentation. Any recipient of an award under this solicitation will be expected to submit to the National Archive of Criminal Justice Data (NACJD) all data sets that result in whole or in part from the work funded by the award, along with associated files and any documentation necessary for future efforts by others to reproduce the project's findings and/or to extend the scientific value of the data set through secondary analysis.

In addition to these deliverables (and the required reports and data on performance measures), NIJ expects scholarly products to result from each award under this solicitation, taking the form of one or more published, peer-reviewed, scientific journal articles, and/or (if appropriate) law review journal articles, book chapter(s) or book(s) in the academic press, technological prototypes, patented inventions, or similar scientific products.

NIJ expects that there will be an equal effort to make the research findings accessible to practitioner and policymaker audiences.

The Goals, Objectives, and Deliverables are directly related to the performance measures that show the completed work's results, as discussed in the Application and Submission Information section.

Priority Areas

The Department of Justice is committed to advancing work that promotes civil rights and racial equity, increases access to justice, supports crime victims and individuals impacted by the justice system, strengthens community safety and protects the public from crime and evolving threats, and builds trust between law enforcement and the community.

1. Priority Considerations Supporting Executive Order 13985, *Advancing Racial Equity and Support for Underserved Communities Through the Federal Government*

Consistent with this Executive Order, the term “underserved community” refers to a population sharing a particular characteristic, as well as a geographic community, that has been systematically denied a full opportunity to participate in aspects of economic, social, and civic life or whose members have been historically underserved, marginalized, and adversely affected by inequality. Such communities include, among others, Black people, Hispanics and Latino/a/e people, Native American and other Indigenous peoples of North America (including Alaska Natives, Eskimos, and Aleuts), Asian Americans, Native Hawaiians, and Pacific Islanders.

In support of Executive Order 13985, OJP will:

A. Give priority consideration to applications that propose research project(s) that will address issues related to racial equity and the removal of barriers to access and opportunity for communities that have been historically underserved, marginalized, and adversely affected by inequality, when making award decisions.

To receive this consideration, the applicant must describe how the proposed project(s) will address potential inequities and barriers to equal opportunity, and/or contribute to greater access to services for underserved and historically marginalized populations.

B. Applicants should provide a detailed description of the strategies to implement this research project and address the research questions. Design elements should follow directly from the research project’s goals and objectives and address the program-specific information noted in the solicitation. Applicants should describe the research methodology and analysis plan in detail and demonstrate the validity and usefulness of the data they will collect. Applicants should consider the rigor and soundness of the methodology and

analytical and technical approaches for the proposed research and address the feasibility of the proposed project and potential challenges or problems in carrying out the activities.

If the applicant is seeking priority consideration for Priority 1(A), it should address in this section how the proposed project(s) will address issues related to racial equity and/or the removal of barriers to access and opportunity, and/or contribute to greater access to services, for communities that have been historically underserved, marginalized, and adversely affected by inequality.

3. Potential Impact.

Applicants should describe the potential impact of the research and how it may inform or improve criminal or juvenile justice-related policy, practice, or theory in the United States. The applicant should include a discussion of the proposed dissemination plan to produce scholarly products and to make information available to broader interested audiences, such as criminal or juvenile justice practitioners or policymakers.

4. Capabilities and Competencies.

 - Demonstrated awareness of the state of current research.
2. Project Design and Implementation (quality and technical merit) (50%).
 - Feasibility of proposed project.
 - Soundness of methods and analytic and technical approach to addressing the stated aim(s) of the proposed project.
 - Awareness of potential pitfalls of proposed project design and feasibility of proposed actions to minimize and/or mitigate them.
 - Feasibility of completing the deliverables noted in the solicitation.
3. Capabilities and Competencies (capabilities, demonstrated productivity, and experience of the applicant organization and proposed project staff) (15%)

- Qualifications and experience of proposed project staff (that is, the principal investigator, any and all co-principal investigators, and all other individuals (and organizations) identified in the application (regardless of “investigator” status) who will be significantly involved in substantive aspects of the proposed project).
- Demonstrated ability of the applicant organization to implement the proposed strategies and manage the effort.
- Relationship between the capabilities/competencies of the proposed project staff (including the applicant organization) and the scope and strategies of the proposed project.

4. Potential Impact (20%)

- Potential for a significant scientific or technical advance(s) that will improve criminal/juvenile justice in the United States.
- Potential for significantly improved understanding of the stated criminal/juvenile justice problem.
- Potential for innovative solution to address (all or a significant part of) the stated criminal/juvenile justice problem.
- Strength and feasibility of the proposed dissemination plan to produce scholarly products (such as published, peer-reviewed, scientific journal articles, book chapter(s) or book(s) in the academic press, technological prototypes, patented inventions, databases, standards or similar scientific products) as well as make summary information available to broader interested audiences, such as criminal justice practitioners or policymakers.

5. Budget (0%)

In addition, peer reviewers will consider and may comment on the following additional items in the context of scientific and technical merit.

- Alignment of the proposed budget with proposed project activities.
- Total cost of the project relative to the perceived benefit (cost effectiveness).
- Appropriateness of the budget relative to the level of effort.
- Use of existing resources to conserve costs.

Other Review Criteria

Other important considerations for NIJ include geographic diversity, strategic priorities (specifically including, but not limited to, those mentioned above relating to priority areas), available funding, past performance, and the extent to which the Budget Worksheet and Budget Narrative (Web-based form) accurately explain project costs that are reasonable, necessary, and otherwise allowable under federal law and applicable federal cost principles.

Review Process

Applications submitted under this solicitation that meet the basic minimum requirements, will be evaluated for technical merit by a peer review panel(s) in accordance with OJP peer review policy and procedures using the stated review criteria listed above.

OJP screens applications to ensure they meet the basic minimum requirements prior to conducting the peer review. Although specific requirements may vary, the following are common requirements applicable to all OJP solicitations:

- The application must be submitted by an eligible type of applicant.
- The application must request funding within programmatic funding constraints (if applicable).
- The application must be responsive to the scope of the solicitation.
- The application must include all items necessary to meet the basic minimum requirements.

- The application, if submitted by an applicant that is a DOJ High Risk Grantee, or is designated “high risk” by a federal grant-making agency outside of DOJ, must not have been determined by the NIJ Director to pose a substantial risk of program implementation failure, based on 1) the applicant’s lack of sufficient progress in addressing required corrective actions necessary for removal of the DOJ High Risk Grantee (or non-DOJ high risk) designation, 2) the nature and severity of the issues leading to or accompanying the DOJ High Risk Grantee (or non-DOJ high risk) designation, and/or 3) the applicant’s expected ability to manage grant funds and achieve grant goals and objectives.
