At 8:32 a.m., Vice-Chairman Jacobson opened the public hearing regarding a Conditional Use Permit Application made by Luis Novoa to allow for an Auto Sales Commercial Business in an AG zoned district. Because of the COVID-19 restrictions, Pam Holbrook, Zoning Administrator explained it was approved unanimously without any objections at their public hearing. At 8:35 a.m., Vice-Chairman Jacobson closed the public hearing. Motion was made by Commissioner Hagan and seconded by Commissioner Stewart to approve the Conditional Use Permit Application for Luis Novoa with the stipulation of no more than 10 cars at one time and all in working order; Resolution #2010-11. At 8:37 a.m., Vice-Chairman Jacobson opened the public hearing regarding Zoning comprehensive plan update. Keith Marvin did not appear because of the COVID-19 restrictions. Pam Holbrook explained the changes made. At 8:42 a.m., Vice-Chairman Jacobson closed the public hearing. Motion was made by Commissioner Stewart and seconded by Commissioner Hagan to table this item until the April 17, 2020 meeting. Aye: Stewart, Kugler, Hagan, Jacobson. Nay: None. Absent: Rickertsen. Motion carried.
