INTRODUCTION

Purpose of the Guide

This guide has been created in order to bring together in one listing, all the records that exist in this Archives that relate to The Presbyterian Church in Canada's (The PCC) involvement in the administration and operation of **Cecilia Jeffrey Indian Residential School and Birtle Indian Residential School from 1925 onwards**, as well as its work with Aboriginal peoples in the area of healing and reconciliation.

Note:

The majority of residential school records held by The Presbyterian Church in Canada date from 1925 and concern only two schools, Cecilia Jeffrey Indian Residential School and Birtle Indian Residential School. Many of the national office records pre-1925 became the legal property of The United Church of Canada (Archives) as a result of the 1925 Church Union property division. Although the two repositories for the dates around 1925 may overlap, the majority of the earlier records relating to PCC residential schools are lodged with the United Church Archives office in Toronto.

How to Use the Guide

This guide is divided into sections, with each section representing a specific body (ie. committee, board, department, agency, organization, or individual) of The PCC that has produced records that in some way relate to the residential schools. Within each section you will generally find an administrative history or biographical sketch, a scope and content note, and a file list.

The administrative history/biographical sketch provides information about the body that created the records, while the scope and content note provides information about the records themselves, such as how they have been arranged and organized. The file list, in turn, is the primary area. In it, you will see a complete listing of those files generated by that particular body which in some way relate to the residential schools. A descriptive title for each file is given, along with the dates of creation of the records within that file, and a unique reference number.

To use the guide, therefore, browse the sections. Within each section, read the administrative history and scope and content notes to get a better idea about the department, board, or organization and the records it created. Then browse through the file list and identify those files which you would like to view. Provide the archivist with the unique reference numbers for those files and he/she will retrieve the files and bring them out to you to view in the reading room of the Archives.

Please note that the Women's Missionary Society (Western Division) was the major PCC body directly involved in the administration and operation of the residential school after 1925. The W.M.S. section of the guide is therefore the primary source for files relating to the running of the schools and contains approximately 60% of the records described in this guide. The majority of records from the other boards, agencies and departments of The PCC such as the General Board of Missions/Board of World Mission or the Life and Mission Agency relate more to healing and reconciliation initiatives of The PCC as opposed to actual administration of the schools. The records of the synods, presbyteries, congregations and the Woman's Foreign Missionary Society document the supportive and advisory role of these groups or church courts in sending supplies to the schools, receiving reports and providing feedback, and raising awareness about the work of the residential schools.

More current records, which have not yet been transferred to the Archives, are still held by the relevant offices (Assembly Council, Assembly Office, W.M.S. (W.D.), Life and Mission Agency, Justice Ministries and Canada Ministries). The records relevant to residential schools are concerned with ongoing reconciliation work and litigation issues as opposed to the actual administration and operation of the schools. The active office records relate to working groups, healing funds and projects, studies, workshops, training sessions, and resources. Additional accruals of these records to the Archives are expected.

Restrictions

Personnel files are restricted for 75 years from the latest date in that file. Some records of a legal nature are also restricted. For further details, please consult with an archivist.

BRIEF ADMINISTRATIVE HISTORY OF THE RESIDENTIAL SCHOOLS

The Presbyterian Church in Canada's involvement in the residential school system for aboriginal people spanned almost nine decades from the mid-1880s until 1969 when the residential schools became the full responsibility of the Federal Government. In total, the church operated eleven residential schools (see page 9 for a complete list). However, at the time of Church Union in 1925, responsibility for the majority of these schools was transferred to the newly formed United Church of Canada. Only two schools – Birtle School in Manitoba and Cecilia Jeffrey School in Kenora, Ontario – remained the responsibility of The Presbyterian Church in Canada (PCC).

The PCC first began its mission work with aboriginal people in Canada in the mid-1860s. One prominent aspect of this outreach right from the start was education - especially of children - and day schools were established on a number of reserves. By the early 1880s, however, the Federal Government became focused on a system of off-reserve, residential (ie. “boarding”) schools for the education of aboriginal children, rather than the further development of day schools.¹ The Presbyterian Church in Canada agreed and began partnering with the government in the establishment and operation of new schools. Generally speaking, the Church was responsible for operating the schools while the government provided funding and oversight, and established the policies under which the schools were to be administered.

Administratively, it was the Foreign Missions Committee of The Presbyterian Church in Canada, under the authority of the Church's highest court - the General Assembly – which assumed responsibility over the operation of the schools. The Woman's Foreign Missionary Society (Western Division), assisted this committee by raising funds and promoting the work amongst its members. Over time this relationship changed, however, and the Women's Missionary Society (W.M.S.) assumed a greater role in the administration of the schools. This shift was completed in 1927 when the General Board of Missions of The Presbyterian Church in Canada agreed that “management of all Indian Boarding Schools be under the care and supervision of the W.M.S. (Western Division).”² The W.M.S. (W.D.) continued in this capacity until 1969 when the schools became the full responsibility of the Federal Government.

The residential schools were financed largely through a per capita grant given to the WMS by the government, ie. a certain amount was provided for each student at the school. This grant was to cover items such as food, clothing, school and building supplies,

salaries (except the Principal and Matron), and general maintenance needs. The buildings themselves were owned by the government and any capital improvements or expenditures rested with them. The WMS, in turn, paid the Principal and Matron's salaries, as well as any additional spending required to meet the operational needs of the school. Budgeting within the per capita limits proved difficult and was a constant and ongoing concern to the Principal and the WMS. Beginning in 1957, the government assumed a greater role in the financing of the schools and the per capita grant system was replaced with one in which the schools were reimbursed for actual expenditures based on budgeted allocations.³

The day-to-day administration of the schools largely rested with the Principal, who was appointed by, and reported to, the W.M.S. (W.D.). As head of the school, the Principal was responsible for a wide-variety of functions including hiring and managing staff, overseeing the students, ensuring the maintenance of the building and property (including the farm), managing the school's daily finances, and maintaining discipline.

Other staff at the schools generally included the teachers, the Matron (who was often the wife of the Principal), Boys' and Girls' Supervisors, Cook, Laundry Matron, Sewing Matron, Nurse, Engineer, Farm Manager, and a Night Watchman. The staff were generally hired by the Principal in consultation with the WMS, and their salaries were paid for out of the per capita grant received from the government. This changed slightly in September 1954 when the Department of Indian Affairs took over direct responsibility for the hiring and paying of the teachers in the schools⁴.

The curriculum in the schools also changed over time. The schools taught Grades 1 to 8. However, up until the mid-1940s the students were on a "half-day" system. This meant that half their time was spent in classroom learning while the other half was spent in vocational training. For boys this primarily meant work on the school farm, although other manual training was involved as well. For girls it usually involved training in sewing, dress-making and cooking. This "half-day" system also meant that it took longer for students in a residential school to complete the academic curriculum. By the late-1940s the students at both Birtle and Cecilia Jeffrey were on a full-day system of classroom learning, which was to follow the standard curriculum of the province in which the school was located⁵.

"This year the children went to classes for the whole day, as in other schools. This has given them a much greater opportunity, as a child can complete the work of a grade in a year. The prospects for the future are much better. A goodly number in the Junior classroom will be doing high school work before they are sixteen under the present system. The children's English is improving, so that their Indian language is seldom heard in the playground or around the building. Most of the Indians praise the full-day system, and some see the advantage of entering school early, but some still do not and will not bring their children to school before ten or eleven years of age".

Students that completed Grade 8 could write an entrance examination in order to attend high school classes in the nearest town (Birtle or Kenora). Up until the late 1940s and the introduction of the full-day system, the percentage of students entering high school remained extremely small. In 1949, 300 students attended Birtle and Cecilia Jeffrey, while only 17 of these were in High School.⁶

Christian education was also an important aspect of the daily curriculum at both Birtle and Cecilia Jeffrey, although the number of daily or weekly worship services held, and the form of religious training, varied slightly over the years, and between the two schools. Scripture readings and exercises were usually conducted each morning, while chapel services were often held in the evening. Worship services were held once or twice each Sunday, and a Sunday School was often conducted in the afternoon. Church-related groups such as Mission Bands, Explorers, and C.G.I.T. meetings were also encouraged.

During the 1950s, the demographics of the student populations at both Birtle and Cecilia Jeffrey began to change. Following the revision of the Indian Act in 1951, more and more day schools began to be opened on nearby reserves, which saw fewer local children being sent to the residential schools. As a result, a larger percentage of the students at Birtle and Cecilia Jeffrey were from more distant and remote areas that had no day school of their own⁷. At the same time, the percentage of high school students living at the schools also increased considerably. Beginning in 1951, aboriginal students from across Manitoba and Saskatchewan that were eligible for high school but otherwise had no access to one were brought to live at Birtle, where they could attend classes in the local high school.

“The students are from almost all Protestant reserves in Manitoba and from several in Saskatchewan. A number of them are members of other churches. This is due to the fact that the day schools on the reserves are caring for the younger students and those who are able to attend from their homes. To residential school go those children, who are too distant to attend day school, orphans, those from broken or very bad homes and those who are seeking grades above the day school.”

By the late 1950s and early 1960s, the Residential School system entered a final transition stage as the Federal Government shifted its policy away from segregated residential schools and towards the education of aboriginal students in local public systems. This shift began at Cecilia Jeffrey in 1959 and by 1965 all students living at the school were attending classes in the local public school.⁸ Integration of students in Grades 1 to 8 began at Birtle School in 1962 and was more or less complete by 1966. In 1966, Cecilia Jeffrey Residential School was formally renamed Cecilia Jeffrey Residence.

On March 31, 1969, The Presbyterian Church in Canada's involvement in the operation of the schools ended, and Birtle Residential School and Cecilia Jeffrey Residence were transferred to the Federal Government.

BRIEF ADMINISTRATIVE HISTORY OF HEALING AND RECONCILIATION EFFORTS

By the mid-1980s a greater recognition was awakening within The Presbyterian Church in Canada of its part in the painful legacy of church, government and First Nations relations - including its involvement in the Residential Schools - and steps began to be taken to “hear and respond” more sensitively to the agendas of First Nations people.⁹

In 1989 a National Committee on Native Ministry was established. Shortly thereafter, the Church joined the Aboriginal Rights Coalition (renamed the Indigenous Rights Program of KAIROS: Canadian Ecumenical Justice Initiative), and in 1993 a Residential Schools Working Group was formed. Draft work on an apology to Aboriginal peoples was also begun in early 1991, culminating in the 1994 adoption of the Church’s “Confession” by the 120th General Assembly of The Presbyterian Church in Canada. This confession was formally presented at the Forks National Site in Winnipeg on October 8th, 1994. Phil Fontaine, Grand Chief of the Assembly of Manitoba Chiefs, received the confession on behalf of First Nations people.¹⁰

Since then, The Presbyterian Church in Canada has embarked on a number of initiatives with the goal of greater healing and reconciliation with Aboriginal peoples.

In 1995, The Rev. Dr. Allan McPherson and eighteen other members of the Church, attended the “Sacred Assembly”, a four day event called by Elijah Harper to “bring together Aboriginal and non-Aboriginal spiritual leaders for the purpose of providing counsel and promoting reconciliation”.¹¹

In 1996 work began on a healing fund initiative which resulted in the launching of the “Journey to Wholeness” campaign in April 1998. A “Journey to Wholeness Campaign Committee” guided the initiative, which lasted until March 31, 2000 and raised more than \$280,000 for a variety of healing-related projects.¹²

On the legal side, the first claim relating to residential schools was filed against The Presbyterian Church in Canada in 1998. By 2003 there were a total of 246 claims¹³. On February 13, 2003, a settlement agreement was signed by The Rev. Stephen Kendall, Principal Clerk, on behalf of The Presbyterian Church in Canada, with the Federal Government. This agreement outlined the “relative financial burden

each will bear in trying to repair harm done to students at residential schools administered by The Presbyterian Church in Canada.”¹⁴ Under this agreement, the Church’s share was \$2,100,000 and this was set aside in a “Residential Schools Settlement Fund”.¹⁵ At the same time, two additional funds were created: the “Residential Schools Resolution Fund” (\$500,000), sometimes called the Implementation Fund, designed to provide the resources needed to ensure the Church meets its commitments under the agreement; and the “Residential Schools Healing and Reconciliation Fund” (\$500,000) designed to complement the Journey to Wholeness Fund, and allow the church to “initiate and participate in education, and healing and reconciliation initiatives and programs.”¹⁶

In 2004 the Residential Schools Working Group was replaced with a one-year Healing and Reconciliation Task Force, designed to establish a “national strategy for engaging congregations in the healing process with aboriginals”.¹⁷ This work resulted in the formation of a Healing and Reconciliation Design Team in 2005.

In 2006, the General Assembly approved the work of the Design Team and established the “Walking Together” program, to be administered through the Justice Ministries department of the Life and Mission Agency. This program has five goals: to provide support and/or seed funding for local initiatives; to encourage and support activities for youth; to invite other denominations to engage in a Leaders tour or initiative, with reference to the model of Ten Days for Global Justice; to develop and distribute resource materials; and to establish and support a local resource team to further healing and reconciliation in the years to come.¹⁸

To assist with the implementation of the program, a Healing and Reconciliation Animator was hired in September 2006, and a Healing and Reconciliation Advisory Committee was formed in December 2006. One of the primary responsibilities of this committee is to provide funding for various projects through the newly formed “Native Ministries Healing and Reconciliation Fund” (see footnote 15) and “Healing and Reconciliation Project Fund”.

In 2007, the “Residential Schools Settlement Agreement” between the Government of Canada, the churches, and representatives of former students, came into effect. This agreement provided a system of compensation for former students of the residential schools, and also led to the creation of the Truth and Reconciliation Commission of Canada. Under this agreement, The Presbyterian Church in Canada has also agreed to provide copies of all documentation relating to its involvement in the residential schools system in the hopes that they will assist the Truth and Reconciliation Commission to “learn the truth about what happened in the residential schools and to inform all Canadians.”¹⁹

LIST OF RESIDENTIAL SCHOOLS OPERATED BY THE PRESBYTERIAN CHURCH IN CANADA²⁰

Ahousaht Residential School, British Columbia

A day school was opened in 1896. In 1902 it started taking on boarders and in 1903 it was accepted as a residential school by the Federal Government. It became the responsibility of the United Church of Canada after 1925.

Alberni Residential School, British Columbia

A day school was opened in 1890. It became a boarding/industrial school in December 1892. It became the responsibility of the United Church of Canada after 1925.

Birtle Residential School, Manitoba

Birtle Residential School began as a day school in 1884 and was converted to a boarding or “residential” school in December 1888. Following Church Union in 1925, responsibility for the school remained uncertain until 1927 when the Dominion Property Commission assigned it to The Presbyterian Church in Canada. The following served as Principals of Birtle School after Church Union: Mr. H.B. Currie (1927-1929); Rev. E.H. Lockhart (1929-1942); Mr. A.E. Candy (acting Principal 1942); Mr. Roy Webb (1942-1945); and Mr. N.M. Rusaw (1945-1969). Mr. Rusaw’s title was changed from Principal to Administrator in 1968. Responsibility for the school was transferred to the Federal Government in 1969.

Cecilia Jeffrey Residential School, Shoal Lake, Ontario (first location)

Cecilia Jeffrey Residential School was built in the summer and fall of 1901, and was opened in January 1902. It was located on Shoal Lake, 45 miles from Kenora. Following Church Union in 1925, responsibility for the school remained uncertain until 1927 when the Dominion Property Commission assigned it to The Presbyterian Church in Canada. The original school building closed in 1929.

Cecilia Jeffrey Residential School, Kenora, Ontario (second location)

A new building for Cecilia Jeffrey Residential School, located 3 miles from Kenora, was formally opened and dedicated on November 6th, 1929. The following served as Principals of the Cecilia Jeffrey School after Church Union: Rev. A.D. Menzies (1927-1929); Mr. E.W. Byers (1929-1940); Mr. Douglas Pitts (1940-1948); Mr. T.C. Ross (1948-1951); Mr. R.S. MacCallum (1951-1952); Rev. J.C. E. Andrews (1952-1953); Mr. Eric Barrington (acting Principal 1953-1954); Mr. Ivan Robson (1954-1957); Mr. Howard Neely (1957-1958); Mr. Stephen Robinson (1958-1966); and Mr. Colin Wasacase (1966-1969). Mr. Wasacase’s title changed from Principal to Administrator in 1967. Responsibility for the school was transferred to the Federal Government in 1969.

Crowstand Residential School, Saskatchewan

This school was opened on Jan. 28th, 1889, near Fort Pelly. A new building was erected in 1899. It closed on November 30th, 1915 and a new day school called Cote Indian School was opened in its place in December 1916.

File Hills Residential School, Saskatchewan

An industrial/boarding school was opened c.1888. A new school building was opened in 1910. It became the responsibility of the United Church of Canada after 1925.

Muscowpetung (later known as “Lakesend”) Residential School, Saskatchewan

A boarding school opened c.1888. In 1890 the school was moved to a point nine miles north of the old site. This school closed in June 1894 but was re-opened briefly in 1895 before being closed again in 1896.

Portage la Prairie Residential School, Manitoba

This school opened c.1886 by the women of Knox Presbyterian Church, Portage la Prairie, who formed a group called the “Women’s Sioux Missionary Society”. This society was incorporated into the W.F.M.S. (W.D.) in 1887. A new residence was opened in 1895. It became the responsibility of the United Church of Canada after 1925.

Regina Industrial School, Saskatchewan

This school was opened in 1891 as a Government Industrial School. The school was supported entirely by the per capita grant given by the Indian Department. Additional financial aid was not provided by the W.F.M.S. (W.D.). It was closed in 1910.

Round Lake Residential School, Saskatchewan

A school was opened at this mission in December 1884. In December 1887 a new “boarding” school was opened. It became the responsibility of the United Church of Canada after 1925.

Stoney Plain Residential School, Alberta

A boarding/industrial school was opened c.1889-90. This school was closed in 1893 and the mission was transferred to the Methodist Church in 1894.

Assembly Council

Administrative Sketch:

The Assembly Council was established by the 117th General Assembly in 1991 as a successor to the Administrative Council. The Assembly Council reports to the General Assembly. It is responsible for recommending policies, submitting short and long range plans, recommending budgets and providing general oversight and control of the financial affairs of the Church. The Assembly Council is also responsible for coordinating the work of agencies and committees of The PCC and in this capacity residential schools related issues are often on the Council agenda. Various committees report to Assembly Council including those dealing with healing and reconciliation initiatives of the Church such as the Journey to Wholeness Spending Committee and the Healing and Reconciliation Design Team. The Assembly Council also gives consideration and final decision to cases where it is necessary to undertake legal proceedings and thus any residential schools cases would be referred to Council.

Scope and Content:

Contains minutes, correspondence and reports which document the discussions and decisions undertaken by The Assembly Council in relation to residential schools issues. The minutes and correspondence in both The Assembly Council Executive records and The Assembly Council meeting records contain reference to residential schools and healing and reconciliation activities. There are also minutes, planning files, correspondence, reports and pamphlets from The Healing and Reconciliation Design Team.

The Healing and Reconciliation Design team was created in 2005 as the result of the work of the Healing and Reconciliation Task Force. The Design Team reported to The Assembly Council and eventually presented its report to the General Assembly in 2006. Out of the approval of this report came the establishment of the *Walking Together* program, to be administered through the Justice Ministries department of the Life and Mission Agency; the hiring of a Healing and Reconciliation Animator in September 2006 and the formation of a Healing and Reconciliation Advisory Committee in December 2006. The Healing and Reconciliation Design Team wrapped up its work in late 2006.

Board of Congregational Life

Administrative Sketch:

The Board of Congregational Life was established by the 98th General Assembly in June of 1972 as an agency for the support and encouragement of congregational life and mission within The Presbyterian Church in Canada. A protem Board was appointed in June of 1972 to serve until the 1974 General Assembly. Programming began on January 1st, 1974, and continued until the Board was dissolved by the action of the 118th General Assembly in June of 1992. The Board brought together under one mandate many of the functions of three former agencies: the Board of Christian Education, the Board of Evangelism and Social Action, and the Board of Stewardship and Budget. With its dissolution in 1992, many of the functions of the Board of Congregational Life became the responsibility of the Life and Mission Agency.

One of the areas of responsibility for the Board was the Church and Society Programme, which existed from 1986-1992, and focused on social justice issues. One of the many issues that the Church and Society Programme devoted time and resources to was Aboriginal rights, including issues surrounding residential schools. After 1992, this programme continued as Justice Ministries of the Life and Mission Agency.

Scope & Content:

Contains general correspondence of Ray Hodgson, Programme Director of Church and Society, in which there are letters referring to healing and reconciliation initiatives. Also contains correspondence, minutes and reports from the Aboriginal Rights Coalition, an ecumenical coalition which The PCC joined in 1989.

Board of Evangelism and Social Action

Administrative Sketch:

The Board of Evangelism and Social Action was established by the General Assembly of 1945. As the name suggests, its main area of responsibility was the promotion of evangelism and social action amongst the congregations of The PCC. The Board also had responsibility for training Church Elders. The Board offered workshops and training programs and produced and disseminated training manuals, study papers, and other literature on evangelism and a variety of current social issues. One of the many issues that the Board of Evangelism and Social Action devoted time and resources to was Aboriginal rights. The Board of Evangelism and Social Action also represented The PCC on inter-church committees and organizations engaged in similar work and presented briefs to the government outlining The PCC's stance on various social and moral issues. The Board was dissolved on December 31st, 1973, its functions being assumed by the Board of Congregational Life.

Board of Home Missions and Social Service

Administrative Sketch:

The Board of Home Missions and Social Service was created in ca. 1921 from a merger of The Board of Home Missions and The Board of Social Service and Evangelism. One of the Board's main purposes was to encourage the growth of The PCC through mission activities in Canada, including work amongst Aboriginal communities. The Board was dissolved c. 1925 with the creation of the General Board of Missions. After 1925, home mission work was continued by the Home Mission section of the new General Board of Missions.

Committee on History

Administrative Sketch:

The Committee on History was first established on June 21, 1879. It seems to have become dormant in the early years of the 20th century but was reactivated at the 1916 General Assembly. The Committee has functioned continuously since that time. The Committee seeks to raise interest in and awareness of The PCC's history through means such as the publication of articles or the celebration of significant anniversaries. The Committee reports directly to the General Assembly. Until 1993, The Presbyterian Church in Canada Archives was the direct responsibility of the Committee. *Presbyterian History*, the twice-yearly publication of the Committee, has been published since March 1957.

General Assembly/Clerks of Assembly/Assembly Office

Administrative Sketch:

The General Assembly is the highest court of The PCC. It meets once each year on the first Sunday in June. The various boards, agencies and committees of The PCC, including those previously involved in the operation of residential schools or those now participating in healing and reconciliation work, report to The General Assembly.

The General Assembly Office (or simply "Assembly Office") was established in 1992, continuing and expanding upon the functions formerly carried out by the Clerk of Assembly's Office. Among other tasks, The Assembly Office has responsibility for organizing and making arrangements for the General Assembly, producing the Acts and Proceedings, acting as the secretariat for the Assembly Council, and providing advice and interpretation services on matters relating to Church law. The Presbyterian Church in Canada Archives is part of the Assembly Office as well with the Principal Clerk acting as Archives supervisor.

Within the Assembly Office are the Clerks of Assembly, the principal officers appointed by the General Assembly. They are responsible for advising the Moderator on procedure and ensuring that the official minutes are correctly recorded. They provide continuity from one Assembly to the next. The Clerks of Assembly are heavily involved in issues associated with residential schools as they are responsible for working on legal issues affecting the denomination. The Clerks of Assembly also serve on various committees of Assembly and Assembly Council and act as representatives of The PCC on boards and committees of ecumenical organizations including groups such as the Ecumenical Working Group on Residential Schools. Since 1971 there has been a Principal Clerk and one or two Deputy Clerks.

Scope and Content:

Contains copies of The Acts and Proceedings of The PCC, correspondence, legal files, minutes and newsletters which document the decisions and actions undertaken at the level of The General Assembly in regards to the operation of residential schools and healing and reconciliation efforts of The PCC. The Acts and Proceedings contain reports of the boards and committees involved in the operation of residential schools or healing and reconciliation work as well as the decisions made by The General Assembly which concern residential schools. Principal Clerk/Assembly Office files contain correspondence, minutes and legal files dealing mainly with legal issues associated with residential schools. The General Assembly Planning files consist of a newsletter from the 2008 General Assembly which provides a brief on the Life and Mission Agency's Healing and Reconciliation Presentations to The General Assembly.

Series: Acts and Proceedings (1875-present)

The Acts and Proceedings of the General Assembly of The Presbyterian Church in Canada are a yearly publication containing the minutes of the General Assembly, reports of the boards and committees of the Church, and statistical information for each congregation across the country. Each year the Assembly appoints a committee to examine the minutes of the previous year's Assembly and attests their accuracy. One copy is then signed by the Clerk, and this becomes the "official" copy. The Acts and Proceedings contain reports of the boards and committees involved in the operation of residential schools or healing and reconciliation work as well as the decisions made by The General Assembly which concern residential schools.

General Board of Missions/Board of World Mission

Administrative History:

The Presbyterian Church in Canada has a very long history of activities in mission fields both at home and abroad. The Home Mission Board was established in 1875. Its purpose was to encourage the growth of the Church through mission activities. It was not until 1882 that the Foreign Mission Board came into existence. Following Church Union in 1925, the work of the Home Missions and Foreign Missions Board were brought together under one administrative body known as the General Board of Missions. At the 1971 General Assembly, the General Board of Missions was restructured and became the Board of World Mission. The first meeting of the Board of World Mission occurred in November of 1971, although final internal organization was not achieved until after the 1972 General Assembly.

The internal structure of the Board of World Mission has undergone many changes during its lifetime. Up until 1991, the main Administrative divisions were: Canada Operations, previously known as Home Missions or Canada Missions; Foreign or Overseas Missions; and Education for Mission. On June 30th, 1992, the Board of World Mission ceased as the Life and Mission Agency came into being. The main Administrative divisions of the Board also experienced restructuring with regard to their mandates during the early 1990s and were eventually incorporated as administrative divisions under the Life and Mission Agency.

Scope and Content:

Contains correspondence, minutes, reports, publications and other records which document the role of the Board of World Mission in carrying out The PCC's work with Aboriginal communities in Canada. General Administration records consist of correspondence, minutes, reports and publications found within the general administrative records of the Board of World Mission. The records represent the various activities in which the Board of World Mission undertook as part of its work with Aboriginal communities. These activities include missionary appointments to reserves and residential schools; the creation of task forces and projects to carry out and evaluate ministries with Aboriginals; and the publication of resources which focused specifically on Aboriginal communities. The records of Canada Operations, the department directly concerned with Aboriginal ministries, contains correspondence, minutes, reports and other records from committees involved in work with Aboriginal communities as well as healing and reconciliation efforts. Canada Operations records also contain correspondence and reports from mission workers in Aboriginal communities, including those communities which were once affiliated with the PCC residential schools.

Sub-Series: Research and Planning

Planned as a new division of the Board of World Mission in 1971, the Research and Planning Committee did not actually come into being until 1973 when E.H. Johnson, the Secretary for Overseas Missions from 1954-1973, became the first Secretary for the department. The purpose of the Committee was to examine the life of the Church and in particular the projects and programs administered by the Board of World Mission in terms of 1) effectively communicating the gospel and 2) effective use of people and resources. Over the life span of the Committee (1973-1980), a number of task forces were created to delve into subject areas of concern to the Board. This committee passed out of existence in 1981 due to a restructuring of the Board.

Series: Canada Operations

Administrative Sketch:

Canada Operations, originally known as Home Missions or Canada Missions was formed in 1925. It focused on mission work in Canada and was established to provide a cohesive base for all mission functions in the country. As part of its mandate, Canada Operations oversaw the work of The PCC with Aboriginal peoples and appointed people to work with Aboriginal communities, including those communities that were affiliated with the two PCC residential schools. Many committees concerned with ministry to Aboriginal peoples, such as the National Native Ministries Committee, reported to Canada Operations. Canada Operations also participated in the earlier healing and reconciliation work of The PCC until its programme mandate was taken over by Canada Ministries of the Life and Mission Agency in July 1992.

Scope and Content:

Contains correspondence, minutes, reports and other records which document the work of Canada Operations with Aboriginal communities in Canada. The minutes of the Executive Committee include reference to Church workers appointed to work in the same areas in which the two PCC residential schools were located. Committees records contain minutes, correspondence, financial statements, reports and other material of the committees involved in work with Aboriginal communities, including healing and reconciliation efforts. The correspondence records contain correspondence, minutes and reports from mission workers in Aboriginal communities, including those communities which were once affiliated with the PCC residential schools.

Sub-Series: Executive Committee Minutes

Series consists of minutes of the Home Missions Executive Committee. These minutes include reference to appointments of ministers or mission workers to the areas in which the two PCC residential schools were located. The minutes also contain brief reports from these workers.

Life and Mission Agency

Administrative Sketch:

The Life and Mission Agency was formed on July 1, 1992 and became responsible for the programme mandates of the former Board of World Mission, Board of Congregational Life, Board of Ministry and Presbyterian World Service and Development. Working with congregations and presbyteries, the Life and Mission Agency is tasked with helping to realize the broader vision and priorities of The PCC, especially in the areas of discipleship, evangelism, social action and justice. As The PCC's work with First Nations peoples in Canada falls under its mandate, the Life and Mission Agency plays a major role in the healing and reconciliation efforts of The PCC, especially through the Justice Ministries and Canada Ministries departments.

Scope and Content:

Consists of correspondence, minutes, publications, reports, financial records and reference files which document the role of the Life and Mission Agency in the residential schools resolution process as well as the healing and reconciliation initiatives of The PCC. The Life and Mission Agency Committee records are comprised of minutes and correspondence which include reference to various aspects of the resolution and reconciliation process undertaken by the Life and Mission Agency. The Executive Staff files contain minutes in which Life and Mission Agency staff share updates and reports on the resolution process and healing and reconciliation work. Department files consist of correspondence and minutes from Justice Ministries and Canada Ministries departments which contain reference to residential school issues. Annual reports include reports of the work of the Canada Ministries department, which is involved in healing and reconciliation activities. Financial records consist of correspondence and ledgers related to financial arrangements for healing initiatives such as the Journey to Wholeness campaign. The records specifically devoted to residential schools contain correspondence, reports, minutes, publications and reference files maintained by the Life and Mission Agency on the topic, especially in the area of resolution and compensation negotiations between The PCC and the federal government. Curriculum and mission studies records are comprised of published mission studies and curriculums developed to raise congregational awareness of issues surrounding residential schools.

Series: Canada Ministries

Administrative Sketch:

Canada Ministries came into being on July 1, 1992 as a department within the Life and Mission Agency and became responsible for the programme mandate of the Canada Operations department of the Board of World Mission. The mandate of Canada Ministries is to “facilitate and support, through personnel and funds, ministries in Canada that are national priorities” (1999 Acts and Proceedings) by working with congregations, mission committees and presbyteries. These national priorities include, among others, ministries to First Nations people and thus Canada Ministries is directly involved with healing and reconciliation initiatives of The PCC. In 1989 a National Committee on Native Ministry was established which is now under the purview of Canada Ministries and several of the missions overseen by Canada Ministries, such as the Saskatoon Healing Circle, work directly with First Nations groups who have been affected by residential schools.

Scope and Content:

Contains correspondence, financial ledgers, planning notes and annual reports which document the work of Canada Ministries in the healing and reconciliation initiatives of The PCC. The records of the Associate Secretary contain correspondence which includes letters focused on the residential school negotiations and the healing activities which Canada Ministries participated in. Presbytery and synod records contain correspondence between Canada Ministries and staff members within the presbyteries or synods where residential schools related issues have come up. The financial records consist of ledgers dealing with the financial aspect of the Journey to Wholeness healing fund. National Native Ministries records contains correspondence, financial records and planning notes related to the National Native Ministries Committee of Canada Ministries. Annual Reports includes annual reports and correspondence related to the submission of the reports. Included in these files are reports from missions and church courts directly involved in various healing and reconciliation activities.

Series: Justice Ministries

Administrative Sketch:

The Justice Ministries department within the Life and Mission Agency was formed in July 1992. It absorbed the responsibilities of the former Church and Society Committee of the Board of Congregational Life. The overall priority for Justice Ministries is to involve individuals, congregations and the courts of the church in faith and justice issues. One of the many issues that Justice Ministries has devoted time and resources to is Aboriginal rights, including healing and reconciliation initiatives. The Walking Together Campaign is administered by the department and the position of healing and reconciliation animator, which was established in 2006, falls under Justice Ministries.

Scope and Content:

Consists of correspondence, minutes, reports and reference files which document the work of Justice Ministries in the healing and reconciliation initiatives of The PCC. The Justice Ministries Advisory Committee records contain minutes, reports and correspondence which include reference to healing and reconciliation efforts. The records of the Associate Secretary contain correspondence and briefs, some of which focuses on residential-school related issues. The Aboriginal issues records include correspondence, minutes and reports of committees or coalitions centered around Aboriginal rights, ministries with Aboriginals, or residential schools. Also included in the Aboriginal Issues series are reference files and correspondence created or compiled by Justice Ministries staff on topics related to Aboriginal issues.

Sub-Series: Justice Ministries Advisory Committee

Members of the Justice Ministries Advisory Committee meet three times a year to plan and review programs, offer advice to the staff members of Justice Ministries and provide input on the Justice Ministries report submitted annually to the General Assembly.

Woman's Foreign Missionary Society (Western Division)

Administrative Sketch:

The Woman's Foreign Missionary Society (Western Division) was founded in 1876 on the initiative of the Foreign Mission Committee of The Presbyterian Church in Canada. It existed until 1914 when it merged with the Women's Home Missionary Society and the Montreal Woman's Missionary Society to form the Women's Missionary Society (Western Division). The Woman's Foreign Missionary Society assisted the Foreign Mission Committee of The PCC in the operation of the residential schools by raising funds and promoting the work amongst its members.

Scope and Content

Contains annual reports, minutes, circular letters, publications and periodicals which include reports and updates on The PCC operated residential schools.

Women's Missionary Society (Western Division)

Administrative Sketch

The Women's Missionary Society (Western Division) was formed in 1914 with the amalgamation of the Montreal Women's Missionary Society, the Woman's Foreign Missionary Society (Western Division) and the Woman's Home Missionary Society. In 1925, the Council Executive of the W.M.S. (W.D.) was made a part of the Assembly's General Board of Missions and from this point on the W.M.S. (W.D.) became a significant part of the mission work of The PCC. Up until c. 1925 the Woman's Foreign Mission Society had assisted in the operation of residential schools by raising funds and promoting its work amongst members. By 1927, however, the General Board of Missions turned the full administration of the schools over to the W.M.S. (W.D.). The W.M.S. (W.D.) continued in this capacity until 1969 when the schools became the full responsibility of the Federal Government. Due to its major role in the operation of The PCC residential schools, the W.M.S. (W.D.) also became involved in the healing and reconciliation efforts of The PCC with participation in initiatives such as the Journey to Wholeness Campaign.

Scope and Content

Contains correspondence, minutes, reports, personnel records, legal files, reference files and other records which document the work of the W.M.S. (W.D.) in the operation of Birtle Indian Residential School and Cecilia Jeffrey Indian Residential School. There are also records that speak to the participation of the W.M.S. (W.D.) in healing and reconciliation efforts. The records of the President contain minutes, reports, correspondence, statements of legal claims and property lists which reference properties associated with the two schools. The records of the Board of Trustees and Treasurer consist of minutes, correspondence and financial statements as well as deeds relating to insurance policies for school properties. The records of the Council include minutes and annual reports which are a rich source of information about the decisions, policies and actions of the W.M.S. (W.D.) in their administration of the residential schools. The records of the Council Executive also contain minutes and annual reports as well as correspondence, committee minutes and reference files created to redress the issue of abuse in the schools. The records of the Organization Department consist of minutes, correspondence and personnel files which include reference to W.M.S. employees who worked at one or both of the residential schools. The series also contains mission studies and other educational material developed by the Organization Department. The National Missions Department series contains correspondence, reports, minutes, personnel records and school quarterly returns related to the administration of the schools. The Finance Committee records are comprised of minutes of the Finance Committee which reference some of the financial aspects of the operation of the schools. The Publications Department series contains minutes, periodicals, subject reference files and publications which contain articles, notes and research pertaining to residential schools and healing and reconciliation efforts of the W.M.S. (W.D.) and The PCC. The W.M.S. Profile series is comprised of integrated reference and personnel files on the employees of the W.M.S., including employees who worked at one or both PCC operated residential schools. Finally, general records contain scrapbooks and photo albums of newspaper cuttings and photos highlighting the various activities of the W.M.S.(W.D.) including photos and newspaper cuttings on The PCC operated residential schools.

Series: Records of the Board of Trustees and Treasurer

From at least 1925, the Board of Trustees has been made up of five members, elected by Council. One member must be from the Council Executive; this member serves as Chairman. The purpose of this Board is to hold the properties of the W.M.S. in trust. The Treasurer, like the President, is an elected, unpaid officer of the Council. Originally, the Treasurer took a much more active role in the administering the accounts of the W.M.S. As the Society became more professionalized, the paid Assistant to the Treasurer began conducting the day to day business, with the Treasurer serving as the authority for transactions. The records of the Board of Trustees and the Treasurer have been maintained as one series, as they were filed together in the W.M.S. office.

Series: Records of the Council

The Council is the legislative body of the W.M.S. With the exception of a period in the 1930's the Council has met annually to receive annual reports and determine policy. Until 1947, the Council consisted of the officers of Council, Council Executive, the Presidents and other officers of the Provincial Boards, representatives from the Provincial Societies, and the President of each Presbyterial Society. After 1947, with the change from Provincial to Synodical boundaries, Synodical officers and representatives naturally replaced the Provincial members. The Council is now made up of elected Synodical delegates, the elected members of Council Executive and Ex-officio and non-voting members. The Ex-officio members are those from other Boards and Councils of the P.C.C.

Scope and Content

This series consists of material from the Annual Council Meetings, including minutes and annual reports. The records are from the period 1915-2009. The minutes and annual reports, especially in the earlier years when the W.M.S. was responsible for managing the residential schools, are a rich source of information on the policies, decisions and actions of the W.M.S. in regards to the operation of The PCC residential schools. More recent minutes and reports provide some information on the healing and reconciliation initiatives the W.M.S. was involved in.

Series: Records of the Council Executive

The Council Executive is the administrative body of the W.M.S.(W.D.). In 1925, it consisted of the Presidents of the Provincial Societies, and other elected members. The elected officers of Council are also members. In the early years, the Council Executive members were nominated by Council, and elected by General Assembly. As the Society gained more autonomy in the 1940's, the Council took over the task of electing members. The Council Executive is in charge of conducting business between the Annual Council Meetings. Should issues arise between the regular Council Executive meetings, the Sub-executive, made up of members of the Council Executive, is empowered to make decisions. Up until 1980, the Departments of the W.M.S. (Finance, Education and Publications) and their various committees were in charge of their respective work. In 1980, the Council Executive established working groups in the areas of Finance, Personnel, Adult Work, Youth/Children's Work, Editorial, and Book Room. The Departments and Committees were subsequently disbanded, with the new Working Groups, under the purview of the Council Executive, taking over all decision-making capabilities. The position of Executive Secretary began in 1952 as the Executive Director of Organization, a salaried post mainly in charge of education. In 1972, after the responsibility for mission work was transferred to the Board of World Missions, the Organization Department was renamed the Education Department, and the Executive Director became the Executive Secretary, now with responsibilities expanded outside the field of education. The Executive Secretary eventually evolved into the head of the W.M.S. staff. For this reason, the Executive Secretary is included in the records of the Council Executive.

Scope and Content:

This series consists of minutes, correspondence, reports and other material relating to the activities of the Council Executive. This includes material on the planning for Council meetings, as well as the preparation of the Annual Report. Included within the Council Executive Meetings records are minutes that contain reference to decisions made and reports received regarding the operation of residential schools. The Executive Secretary and Executive Director files contain correspondence which contains references to residential schools or issues associated with healing and reconciliation efforts of The PCC. Finance Working Group/Finance Core Group records consist of minutes which address requests for money towards healing and reconciliation activities. This series also contains material specifically related to residential schools. It consists of material collected as part of the ongoing effort to redress the issue of abuse in the schools. Minutes and correspondence of committees active in this effort are also included here.

Series: Records of the Organization Department/Education Department

The Organization Department began in 1925, and did just what its name suggests, as well as taking on the work of mission education. Four Organization Secretaries were appointed to work with local groups. The Organization Department also served as the liaison with Auxiliaries, Presbyterials, Provincials, and later Synodicals. In 1952, an Executive Director of Organization was appointed. When the Board of World Missions took over responsibility for missionaries in 1971, the Director of Organization became the Executive Secretary, with expanded responsibility outside the Organization Department. The Organization Department became the Education Department in 1972 and expanded to include the Book Room and Editorial Committees. The Department ceased to exist in 1980 and its responsibilities were transferred to the Working Groups reporting to Council.

The National Missions Department was established in 1925 and as its name suggests, focused on the national work of the W.M.S. (W.D.), including the operation of The PCC residential schools.

Provincials/Synodicals and Presbyterials of WMS

Administrative Sketch:

The local work of the W.M.S. (W.D.) is carried out by Presbyterials and Provincials/Synodicals. The boundaries of the Presbyterials are co-extensive with the Presbytery. Provincial Boards were established in 1914 to oversee the work of the Presbyterials. In 1946-47, the Provincials were replaced by Synodical Societies whose boundaries are co-extensive with the Synods. These local groups, especially the Presbyterials and Provincials/Synodicals located in the same geographical area as the residential schools, received reports of the mission work happening at The PCC operated schools and would have collected supplies to send to the schools.

Scope and Content:

Contains minute books of presbyterials and provincials/synodicals within the W.M.S. (W.D.). Included in these minute books are a few reports and updates on residential schools as well as actions taken by the Synodical or Presbyterial such as sending supplies to the schools or recommending candidates for staff positions at the schools.

Congregational Records

First Presbyterian Church, Kenora

Historical Sketch:

The congregation of First Presbyterian Church, Kenora had its beginnings in 1930 when members of the Knox United Church broke away to re-establish a Presbyterian presence in the community. The first church service was held at the Cecilia Jeffrey Indian Residential School in May 1930 and was led by E.W. Byers, principal of Cecilia Jeffrey. The following year the congregation moved to a building closer downtown and were organized as a formal congregation. The first minister was Rev. W.J. Pellow and he served at the Church until 1931. After the purchase of a manse and adjoining property in 1949, the congregation made a formal decision to build a new church building. The cornerstone was laid in November 1954 and the building was finished by August 1955. The new church was dedicated on June 21, 1956, coinciding with the 25th anniversary of the congregation. First Presbyterian Church maintained many ties with Cecilia Jeffrey Indian Residential School. The congregation of First Presbyterian Church often held services or special events such as turkey suppers at the school. Members of the Cecilia Jeffrey choir would also perform at the Church on special occasions. Several staff members at the school including Ivan Robson and Stephen Robinson, both principals at Cecilia Jeffrey, served as ministers or elders of First Presbyterian Church. On May 30, 1971, a stained glass window was placed in the Church and dedicated to the staff and students of Cecilia Jeffrey Indian Residential School.

Scope and Content:

Contains baptismal, marriage and burial registers from First Presbyterian Church which include names of students who attended Cecilia Jeffrey Indian Residential School. Session minutes contains reference of students and staff at Cecilia Jeffrey. Also contains two histories of First Presbyterian Church which both reference the connections between the school and the Church.

Scope and Content:

Consists of Kay Blake’s diaries/daily journals for the years 1929-1991. The diaries document her day to day activities as she writes about the weather, her family and friends, nursing duties and church activities. Kay Blake also writes about her time at Birtle Indian Residential School and Cecilia Jeffrey Residential School.

Photographs

The Archives holds approximately 1000 photographs of Cecilia Jeffrey Indian Residential School and Birtle Indian Residential School. Although the photographs span the years 1890-1965, the majority are from the 1950s and 1960s. The photographs depict school buildings, staff, classrooms and class pictures, and students engaged in various activities whether work or play. There are also some later photographs of the former school buildings which were taken in the 1990s and 2000s.

These photographs are all kept in the Graphics Collection of the Archives. To view these photographs, please consult with the Archivist.

Note for the Archivists:

The residential school photos held by the Archives were found by doing title and scope and content searches in the Graphics database using the keywords “Indian,” “Aboriginal,” “Native,” “Residential,” “Cecilia Jeffrey,” and “Birtle.” Staff also searched through collections of photographs that have not yet been described in the database. Any photos found as a result of this search were scanned and described. New accessions of residential school photographs that came into the Archives were scanned and described as soon as they were received.

The photographs, approximately 1000 in total, were all scanned and saved on DVDs as .tif files. Photographs that concern healing and reconciliation activities as opposed to photographs taken at the schools during their existence as residential schools were saved on separate CDs. Photographs from the residential schools former staff workers gathering held by The Presbyterian Church in Canada in April 2002 as well as the photographs from the Remembering the Children Winnipeg Event in 2008 can be found on these separate CDs. The DVDs and CDs, which are updated to **October 2010**, can be found in the graphics filing cabinet in a labelled box.
